

Cyber Security

What is Cyber Security?

Cyber security refers to the body of technologies, processes, and practices designed to protect networks, devices, programs, and data from attack, damage, or unauthorized access. Cyber security may also be referred to as information technology security.

In easy words, cyber security means protecting data, networks, programs and other information from unauthorized or unattended access, destruction or change.

Why Cyber Security is important?

Cyber Security is important because government, military, corporate, financial, and medical organizations collect, process, and store unprecedented amounts of data on computers and other devices. A significant portion of that data can be sensitive information, whether that is intellectual property, financial data, personal information, or other types of data for which unauthorized access or exposure could have negative consequences. Organizations transmit sensitive data across networks and to other devices in the course of doing businesses, and cyber security describe the discipline dedicated to protecting that information and the systems used to process or store it. As the volume and sophistication of cyber-attacks grow, companies and organizations, especially those that are tasked with safeguarding information relating to national security, health, or financial records, needs to take steps to protect their sensitive business and personnel information. As early as March 2013, the nation's top intelligence officials cautioned that cyber-attacks and digital spying are the top threat to national security, eclipsing even terrorism.

In today's world, cyber security is very important because of some security threats and cyber-attacks. For data protection, many companies develop software. This software protects the data. Cyber security is important because not only it helps to secure information but also our system from virus attack. After the U.S.A. and China, India has the highest number of internet users.

CHALLENGES OF CYBER SECURITY

For an effective cyber security, an organization needs to coordinate its efforts throughout its entire information system. Elements of cyber security encompass all of the following:

Network security
Application security
Endpoint security
Data security
Identity management
Database and infrastructure security

Cloud security
Mobile security
Disaster recovery/business continuity planning
End-user education

The most difficult challenge in cyber security is the ever-evolving nature of security risks themselves. Traditionally, organizations and the government have focused most of their cyber security resources on perimeter security to protect only their most crucial system components and defend against known treats. Today, this approach is insufficient, as the threats advance and change more quickly than organizations can keep up with. As a result, advisory organizations promote more proactive and adaptive approaches to cyber security. Similarly, the National Institute of Standards and Technology (NIST) issued guidelines in its risk assessment framework that recommend a shift toward continuous monitoring and real-time assessments, a data-focused approach to security as opposed to the traditional perimeter-based model.

MANAGING CYBER SECURITY

The National Cyber Security Alliance, through SafeOnline.org, recommends a top-down approach to cyber security in which corporate management leads the charge in prioritizing cyber security management across all business practices. NCSA advises that companies must be prepared to "respond to the inevitable cyber incident, restore normal operations, and ensure that company assets and the company's reputation are protected." NCSA's guidelines for conducting cyber risk assessments focus on three key areas: identifying your organization's "crown jewels," or your most valuable information requiring protection; identifying the threats and risks facing that information; and outlining the damage your organization would incur should that data be lost or wrongfully exposed. Cyber risk assessments should also consider any regulations that impact the way your company collects, stores, and secures data, such as PCI-DSS, HIPAA, SOX, FISMA, and others. Following a cyber-risk assessment, develop and implement a plan to mitigate cyber risk, protect the "crown jewels" outlined in your assessment, and effectively detect and respond to security incidents. This plan should encompass both the processes and technologies required to build a mature cyber security program. An ever-evolving field, cyber security best practices must evolve to accommodate the increasingly sophisticated attacks carried out by attackers. Combining sound cyber security measures with an educated and security-minded employee base provides the best defense against cyber criminals attempting to gain access to your company's sensitive data. While it may seem like a daunting task, start small and focus on your most sensitive data, scaling your efforts as your cyber program matures.

Reason for drone delivery not possible in densely populated area.

Your dream to get a pizza delivered by a drone or an Amazon drone knocking at the door will remain a dream as researchers have revealed that a drone delivery service is not realistic and may not be possible in densely-pulated areas. The reason is simple: Demand for drone delivery in e-retail is high but the ability to meet that demand is very low. For a city like New York, the optimal design for the test locations, based on all factors, is three drone facilities covering 75% of NYC area and 34% of the population. "Opening a fourth facility increases area and population coverage to 84% and 38%, respectively, but the increase in operation cost is not enough to cover the facility costs," said the researchers from University of Waterloo in Ontario, Canada. "We analyse the tradeoffs between distribution costs and revenues under varying social difficulties with drones like customer preferences and regulatory and technological limitations," said Fatma Gzara, a professor in the Department of Management Sciences at Waterloo. "We then can make educated decisions on how many facilities to open, which services to offer at that facility and which services to make available to customers in certain areas," she added. The new research, published in the journal Transportation Science, looked at how possible and desirable it is to use drones for delivery for e-retailers considering cost and effectiveness in certain population areas and in certain locations. The study, conducted by Gohram Baloch and Gzara, used New York City as an example and looks at data surrounding the Manhattan area. The authors separated the area into boroughs based on population and size. Baloch and Gzara said they chose New York because the world's largest e-retail company, Amazon, first started its 2-hour delivery services in the Big Apple. "Our results show that government regulations, technological limitations, and service charge decisions play a vital role in optimal configurations and drone target markets," said Gzara. "Under current drone landing capabilities, a drone delivery service may not be possible in a densely populated area like Manhattan where demand for such a service is expected to be high," the researchers wrote. e-retailers can reach smaller markets and more price-sensitive customers by possibly offering discounts on dronedelivered orders, the findings showed.

The government has also introduced a Central Victim Compensation Fund (CVCF) scheme, with an initial corpus of Rs 200 crores to enable support to victims of rape, acid attacks, human trafficking and women killed or injured in the cross border firing

UNTOLD STORIES of Delhi Riots by RAJAN SALUJA

I would like to elaborate some bitter truths in Delhi Riots and facts which have emerged through a haze of toxic rhetoric and fake news.

First, the violence was not a spontaneous clash or argument-gone-wrong between two groups of people, supporting or opposing the citizenship legislation. Every riot victim Media officials have talked, Muslim and Hindu, has spoken of the assaulters being complete strangers and outsiders to their immediate colony. In fact, within local communities, Muslims and Hindus have for the most part shielded each other. The pattern of violence and multiple eyewitness accounts all point to a deliberate unleashing of men, armed with swords and irons rods, into targeted areas.

Second, notwithstanding a few good men in the police force who stood their ground and did their job courageously, and notwithstanding the fact that in parts of north-east Delhi, the police too came under ferocious attack, the police, for the most part, has enabled this carnage.

Though Right-wing trolls want to push a religious wedge through the debate over the role of the police, please talk to victims. Once again, you

will find Muslims and Hindus saying the exact same thing — the police, was at best, unresponsive. Hundreds of SOS calls were not taken seriously. Sunita, the wife of Prem Singh, a poor rickshaw puller, who was shot dead when he stepped out to buy milk, was turned away from the police station when she went to file a missing person report. Hari Singh Solanki, whose young son, Rahul, was killed by the mob, told media, "Had the police responded on time my son may have been alive today." The exact same sentiment was echoed by Jitendra Kumar, the owner of Pandit Medicos, a small pharmacy that was burnt. The police failed people of both religions. But the ineptitude, haplessness or callousness was egregiously compounded by reports of communal bias and wilful complicity when it came to police action in Muslim neighbourhoods.

Media persons have met multiple victims who speak of the police charging at their houses alongside violent mobs. They have seen video evidence where policemen too are hurling stones. And there is the bone-chilling video, where young men are lying injured and bleeding on the road, pleading for help as the police purportedly make them sing the national anthem. Faizan, from that video, is dead. Media officials met the family of Kausar Ali, another young man from the video. He is critically injured and in hospital.

The third inconvenient truth: India has failed its riot victims twice over. The usually omnipresent politician who makes sure to insert himself into every photo-opportunity is entirely missing on the ground. Through the week, HT Media Officials have met abjectly poor people, whose poverty has amplified their grief and loss. Most cannot even afford the Rs 800 an ambulance run needs.
