Minutes of Meeting

Date: 15/06/2022

A meeting of Grievance Redressal Committee held on 15/06/2022 at 9.30 AM in the conference room (Admin Block) regarding the complaint received from Vadhika Sharma (B.Tech 1st Year, CSE). Dr. Anju Gandhi (Chairperson, GRC) welcomed all committee members and gave a brief description of the agenda of the meeting.

The matter was thoroughly discussed and all the concerned were called.

Agenda of the meeting:

1. Vadhika Sharma (B.Tech 1st Year, CSE) filed a grievance against Mouroy (B.Tech 1st Year, CSE) about creating Fake IDs of Vadhika Sharma as **vai_d_hu**, **vaidh_ika_** on Instagram and having conversation with other students in the campus.
2. Mouroy also posted videos and photos of Vadhika on different Fake profiles she created.
3. Mouroy also created a fake id on the name of Riya Mukharejee as **_mukerjee_riya_** on Instagram and Whatsapp and made several audios and text conversations with a number of students inside the campus.

The matter was thoroughly discussed and investigated. After several meetings and discussion with committee members, Ms. Palika Sehgal (Himadari girls hostel warden) and concerned students following observations were made:

1. The complaint filed by Vadhika is valid and verified that all above IDs are fake and were created and operated by Mouroy herself.
2. Mouroy also created a Fake ID as **its_yshika** and made a conversation through this ID with Aman (B.Tech 3rd Year, CSE) and posted a photo of Tripti (B.Tech 1st Year, CSE) during her conversation.
3. Vadhika also found guilty of being indirectly involved in these activities and encouraging Mouroy.
4. Vadhika has downloaded a mobile app for making prank calls and she committed that she did this for entertainment purpose and not to harm any individual.
5. A student Jatin (B.Tech 1st Year, CSE) was also involved in this as he was constantly in contact with Mouroy and Vadhika regarding this case.
6. An audio was found in an ongoing conversation between Jatin and Mouroy in which Jatin used abusive language about female.
7. Few more students were found to be indirectly involved in this case. They were aware of all these things but did not report to their mentors or any of the authorities. These are:
 - a. Aditya Raj (B.Tech 1st Year, CSE)

- b. Aman (B.Tech 3rd Year, CSE)
- c. Deepali (B.Tech 1st Year, CSE)
- d. Nancy (B.Tech 1st Year, CSE)
- e. Khushbu (BBA, 1st Year)

Following are the recommendations given by the committee members:

1. Mouroy should be suspended from the college till further orders.
2. Vadhika and Jatin to be suspended from the college for one week.
3. Following students should be given a strict warning of not being involved in any of such indecent activities in future:
 - a. Aditya Raj (B.Tech 1st Year, CSE)
 - b. Aman (B.Tech 3rd Year, CSE)
 - c. Deepali (B.Tech 1st Year, CSE)
 - d. Nancy (B.Tech 1st Year, CSE)
 - e. Khushbu (BBA, 1st Year)

Meeting was concluded with a vote of thanks to all present.
