Minutes of Meeting

The meeting is convened on **22nd February 2023** at **10:30 hrs** and is chaired by the ICC Committee Chairperson Dr. Anita Malik, the Members of the ICC (Internal Complaint Committee), & Women cell (Gender Sensitization). The meeting was adjourned at **13:00 hrs**.

The following members of the ICC Committee were present in the meeting: -

The following points were discussed in the meeting:

- (i) The issue raised by a girl student Ms. Sumaiya (22856 – BCA CTIS) against some hostler students on February 21, 2023 regarding using abusive language on phone on February 19, 2023 late night.
- (ii) As per the statement of Girl's Hostel Warden the identified students are:

- (iii) The case was thoroughly interrogated by the committee members with the help of Ms. Pallika (Girl's Hostel Warden), Mr. Rajesh (Boy's Hostel Warden), Mr. Amarpal and Mr. Sukhbir Hooda (Security Officer).
- (iv) All the suspected students were called before the committee and their

statements were recorded.

At 10:30 hrs,

Mr. Amarpal (Hostel Supervisor) was called to disclose the facts, brief about apprehending the students, and talk about the students involved in the case.

At 11:00 hrs,

Mr. Himanshu Kumar was presented in front of the committee and a recording with his permission was started, in which he kept the facts that his mobile phone was used to place the call, and other students were involved to talk on the phone with the girl.

He admitted that he was drunk on the night the call was placed at around 11 pm on the 19th of February 2023. A bottle of Golfer's Shot was bought from Samalkha, after a contribution from the other students as well. After consuming alcohol, the students called a girl namely, Ms. Sumaiya (22856 - BCA CTIS 1st year) 7705033040, Residing in the Girls Hostel, PIET.

They talked to the girl and his brother using vulgar language, a recording of the conversation was saved by one Qussain Ali, aka Zaid on his phone, and the students had conversations with the girl.

He took the name of one Mr. Suraj Kumar 282017 – B.Tech CSE 3rd year 9534376564, residing in the hostel room number CR 2 who informed him about the event.

He said that Zaid likes that girl, and they assume that if that girl sees their story on a social media platform like Instagram, the girl likes the boy. So, they called the girl after consuming the alcohol. The girl has previously denied talking to them in past.

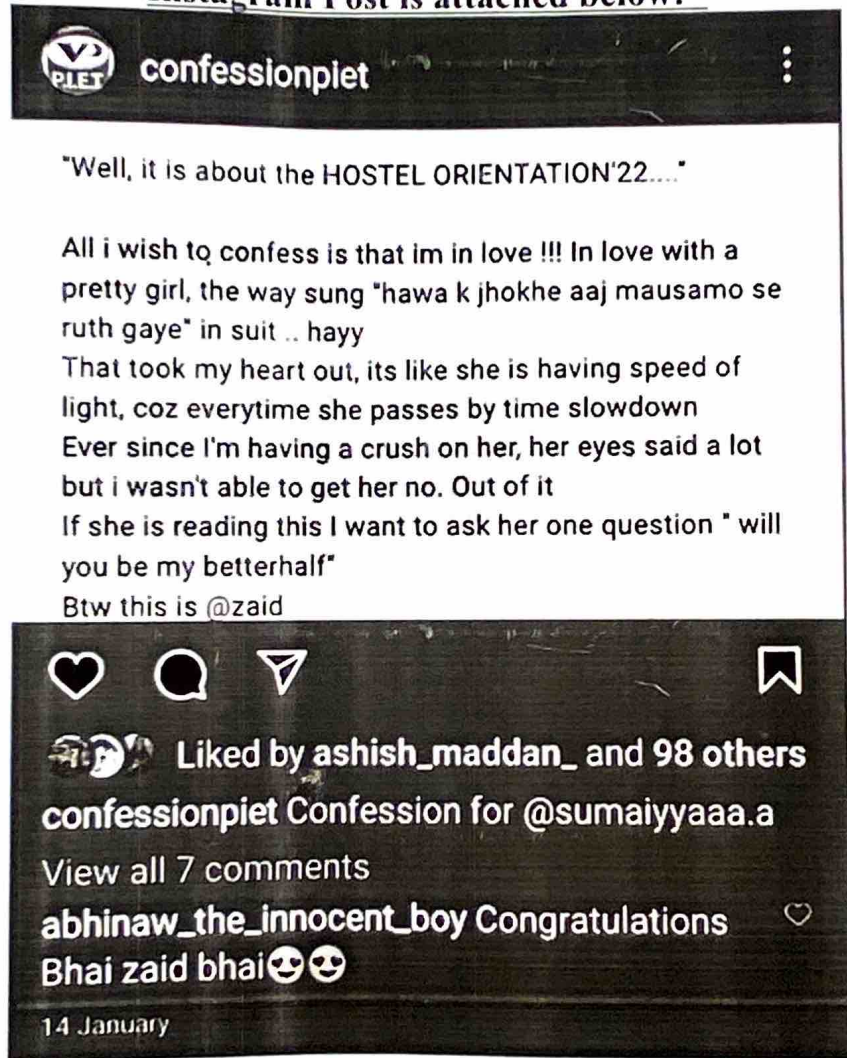
At 11:08 hrs,

Mr. Qussain Ali/ Mr. Zaid was presented before the committee and a recording with his permission was started, in which he disclosed that he was not involved in any activity and informed that he is being formulated in the matter and does not have any role in the case. Later, he accepted that he is involved in the conversation between the students and the girl. He informed the committee that Sumaiya is a girl residing in the Girl's hostel, and the other students told him to call the girl on the night of 19th February 2023 at around 11:00 pm – 11:30 pm. He said that

he went to room number 411, NBH, to Mr. Ankit to recharge his phone. He told that after he went to the room, Mr. Amarpal entered the room just after 2 minutes searching for the students. He told the committee that he does not drink. Furthermore, he was on an Outing that day at around 4 pm with the other students. A post on Instagram was done by some student to defame him, mentioning his Instagram ID.

At 11:52 hrs,

Mr. Vikrant was presented before the committee, and he informed the committee that he is being formulated in the matter, and went to see his friends in room 411, NBH hostelafter a call from Mr. Suraj who told him about the incident. He went from Room number 24, OBH, and went to room number 411, NBH, and did not disclose anything else.

At 12:05 hrs,

Mr. Ankit Raj was presented before the committee and was told that he will be recorded. He disclosed that one Mr. Suraj informed him about the case, and told him to go to his room. After he entered the room, he saw Mr. Tushar, Mr. Vikrant, and Mr. Yash having Chilli Potato, Chips, and Cold drinks.

He also admitted that he was on an outing that day with the other students at around 4 pm to Samalkha.

At 12:12 hrs,

Mr. Tushar Garg was presented before the committee and told he will be recorded for his statements. The statements included his name and details. Furthermore, he said that a student Mr. Suraj called him to approach his room and he saw some students, Mr. Suraj, Mr. Vikrant, Mr. Yash, and Mr. Zaid were already present in that room and saw Mr. Zaid running from the room having an alcohol bottle and were consuming Chips and Cold drinks in that room when Security Officer and Mr. Amarpal came to find Mr. Himanshu.

At 12:30 hrs,

Mr. Yash was presented before the committee, and he informed us that he has no role in the matter. Furthermore, he said that students namely, Mr. Vikrant, Mr. Ankit, and Mr. Himanshu were present in the room after reaching the room at around 9 pm on the night of 19th February 2023. He denied telling the facts and disclosing things.

- (v) The next meeting is scheduled on February 23, 2023 at 2:30 pm in Director's office.
- (vi) The meeting was concluded with vote of thanks.
