Objectives:

The anti-ragging committee (ARC) is responsible for spreading awareness and sensitizing students about ragging and its consequences. The committee determines and finalizes the institute's anti-ragging measures, following the directives from the Honorable Supreme Court of India, UGC, and AICTE, New Delhi.

 ARC meetings should be held annually or every week, depending on the frequency of complaints.

• Ensure that students and parents/guardians submit an undertaking or affidavit in the prescribed Performa during the admission process.

• We must take the necessary measures to ensure that there are no instances of ragging on campus.

• All members of the institute, including senior students and freshmen, receive communication about measures to prevent ragging.

• The establishment of the Anti-Ragging Squad and a Mentoring Cell on Ragging are among the measures to ban ragging and eradicate its scourge, as defined by the applicable rules.

• It's crucial to follow the guidelines of the applicable regulations, as established by the regulatory authorities.

• Timely circulation of action taken report to the concerned authorities against anti-ragging in the institute.

 The goal is to stop and eliminate ragging in the surrounding area, the institute campus, and the residence hostels for both boys and girls.

• Aim to establish a secure and encouraging atmosphere for students by firmly upholding a zero-tolerance policy against bullying.

 Aim to sensitize students about the harmful effects of ragging and the disciplinary/criminal actions that will be taken against offenders.

Aim to foster a culture of respect, empathy, and unity among students.

Functions/Responsibilities:

 To disseminate information on the consequences of ragging through orientation and awareness programs.

 To form and deploy an anti-ragging squad to regularly monitor the campus, hostels, and neighbourhood.

- To take preventive measures to avert any ragging incidents.
- To investigate complaints related to ragging promptly and impartially.
- To take appropriate disciplinary actions against individuals found guilty of ragging, which may include expulsion, suspension, or legal action as per the severity of the incident.
- To publicize the committee members' contact information will make incident reporting easier.
- We regularly review and update the anti-ragging policy to guarantee its effectiveness.

Action Taken Report: 2021-22

- 1. The anti ragging committee is formed as per directions given by the governing bodies and the honourable Supreme Court of India
- 2. Awareness sessions are organised for every student, it is also informed that ragging in any form is prohibited at the institution, and that any student who disobeys the norms and regulations established by the Honorable Supreme Count of India and other governing bodies would be punished. According to the Indian Penal Code and the college code of conduct, this will be a punishable offense.
- 3. The purpose of the Anti Ragging Squad is to patrol the common areas and core facilities, such as the cafetria, Playground, and Netcafe.
- 4. During academic hours, all HoDs are required to stay alert and make sure that there are no instances of ragging in their particular blocks, as directed by the director, sir.
- 5. To raise awareness, awareness seminars are arranged for recently admitted students. Students may find information on ragging on the institute's website, as well as in the prospectus and in admission form.
- 6. In order to facilitate prompt communication in the event of a ragging incidence, the website provides the anti-ragging committee's contact information.
- 7. According to the AICTE and UGC guidelines, the academic department is required to provide newly accepted students with an anti-ragging form or affidavit (for parents/guardians and student's affidavit), and they are requested to present the properly completed document from both the students and their parents/guardians. Student's affidavits is kept in their own file in the academic section.
