#### **PPE Kits**



This Memorandum of Understanding (MOU) is entered into by and between

M/s. Mahadev Exports, 113, Sector 2, Part-2 HUDA, Panipat, Haryana, India, which expression shall, unless repugnant to the context thereof, mean and include its affiliate, subsidiaries, and their successors and permitted assigns of the FIRST PART through its Managing Director, Neeraj Ahuja

#### And

Panipat Institute of Engineering & Technology (PIET), with a registered address at 70 Milestone GT Road, Samalkha, Panipat-132102, Haryana, India, hereinafter referred to as PIET, which expression shall, unless repugnant to the context thereof, mean and include its affiliate, subsidiaries, and their successors and permitted assigns of the SECOND PARTY through its Director, Prof. (Dr.) Shakti Kumar;

are referred collectively, as "Parties" or individually as "Party." This MOU is based on the principles of collaboration for the benefit of society, equality, and reciprocal benefit of parties.

#### WHEREAS.

- A. MAHADEV EXPORTS is engaged in the Manufacturing, Distribution, Import, and Export of Non-Woven PPE Kitş and surgical Gowns
- B. PIET is engaged in providing Engineering, Management and Pharmacy Education and Research, Design and Development
- C. M/s. MAHADEV EXPORTS has approached PIET to provide Research, Design, and Development consulting services to M/s. Mahadev Exports on the terms and conditions appearing hereinafter.

IN WITNESS WHEREOF THE PARTIES HAVE AGREED TO BIND THEMSELVES WITH THE FOLLOWING TERMS AND CONDITIONS:

MoU between PIET Samalkhaand M/s Mahadev Exports

Purpose: The Parties recognize the social and medical need for designing and developing a Personal Protection Equipment (PPE) kit that can be used by the medical staff and others during the fight against COVID-19 in India. Parties understand and agree that through mutual collaboration of Research Design and Development facilities of PIET and manufacturing facilities at Mahadev Exports, mutual benefits can be derived to meet the existing shortage of PPE in India during the Corona Virus strike. The acute shortage of PPE is causing risk to the lives of Medical, paramedical staff and other individuals engaged in the War against Corona. Apart from social benefits, this kind of collaboration may result in financial benefits as well. The purpose of this MOU is to define the areas for fundamental, academic research in which the Parties desire to work together in their mutual benefit to foster a collaborative framework in the Field with a view to benefiting from each other's initiatives and working procedures. To both Parties.

#### 2. Terms of agreement:

This Agreement shall be effective from 5<sup>th</sup> March 2020 (commencement date) and shall remain valid for 1 (One) year from the commencement date and thereafter shall stand terminated, automatically. However, unless terminated, the agreement would be open to renewal subject to mutual written consent between both parties.

- M/s. Mahadev Exports and PIET agree to the following general framework of cooperation. Cooperation in other areas if required shall be finalized through mutual agreement later.
  - A. Constituents of PPE Kit: The parties agree that the PPE kit required to be designed and developed shall consist of the following articles:
    - Dangri: One Piece
    - ii. Face Mask (3 Ply): One Piece
    - iii. Gloves Ster. (size 7.5): One Pair
    - iv. Ankel Shoes: One Pair
    - v. Protective Glass: One Piece
    - vi. Bed Sheet: One Piece
    - vii. Waste Carry Bag: One piece
  - B. Research, Design and Development: The two parties agree that entire designing and development shall be carried out at PIET with mutual consultation.
- Both parties agree that Mahadev Exports as recommended by PIET shall supply the entire raw material required for designing the PPE Kit.
- The PIET agrees to design modifications till the PPE Kit is accepted/certified by DRDO as fit to be used by its users.
- Consultancy Charges: Once PPE kit is accepted/certified by DRDO as fit to be used PIET shall charge a, one-time consultancy charges of Rs.5,00.000/- (Rupees Five Lakh Only).
- 7. Any subsequent consultancy, design, and development, modification(s) after the

ATDENTIALITY: Both parties shall not, during or subsequent to this Agreement use interest and information for any purpose whatsoever on behalf of each other or disclose the same to any third party. It is understood that the said Confidential Information shall remain the sole property of each party. Both parties further agree to take all reasonable precautions to prevent any unauthorized disclosure of such Confidential Information.

- Neither party shall be held legally liable, whether directly or indirectly, for the acts & services of each other.
- 10. Both Parties agree to not approach each other,s regular or contractual employees/consultants directly or indirectly for any business, job, contract, assignment, etc. for a term of 1 (one) year from the last date of services provided.

#### 11. FORCE MAJEURE:

If either party shall be considered in breach of this Agreement or in default of its obligations hereunder because it fails to perform or observe any or all of the terms of this Agreement resulting directly or indirectly from causes beyond the reasonable control of such party, such as but not limited to, acts of God, civil or military authority, acts of the public enemy, war, riots, civil disturbances, insurrections, accidents, explosions, fires, earthquakes, floods, transportation embargoes, epidemics, acts of government, its agencies or officers, or any other legitimate cause beyond the reasonable control of the parties, the party whose performance is affected or is likely to get affected thereby, shall notify the other party of the occurrence of such cause, and the time allowed for performance by the affected party will be extended for the duration of such cause. However, if as a consequence of such cause, performance by a party under this Agreement shall be prevented for a period longer than 15 days, then the other party shall have the right to terminate this Agreement after a 15 (fifteen) days' notice. The terms of termination under this condition will be with no liabilities or penalties.
